



SEASPAN TAKES DELIVERY OF NEW CONTAINERSHIP

CSCS Panama is the First of Six Newbuildings Scheduled for Delivery in 2008

HONG KONG, CHINA - May 15, 2008 /CNW/ - Seaspan Corporation (NYSE:SSW) today announced that it has accepted delivery of its 30th vessel, the CSCS Panama. The 2,500 TEU newbuilding, which was constructed by Jiangsu Yangzijiang Shipbuilding Co., Ltd. and is the first of its size in Seaspan's fleet, was delivered on May 12, 2008, approximately sixteen weeks ahead of its original contractual delivery date.

The CSCS Panama is subject to a time charter with China Shipping Container Lines (Asia) Co., Ltd. for a twelve year period. CSCS Asia is a subsidiary of China Shipping Container Lines Co., Ltd., the world's seventh-largest liner company in terms of shipping capacity.

Gerry Wang, Chief Executive Officer of Seaspan, commented, "We are pleased to take delivery of the CSCS Panama nearly four months ahead of schedule. This vessel is the first in a series of eight 2,500 TEU vessels to be built by Jiangsu and chartered to CSCS Asia, a major liner company with a strong credit history. With the delivery of the CSCS Panama, we have further diversified our high-quality vessel portfolio and strengthened our fixed revenue and cash flow streams. We are continuing to execute our growth strategy and we remain on track to take delivery of 38 remaining newbuildings over the next three years, including five additional vessels in 2008."

About Seaspan

Seaspan owns containerships and charters them pursuant to long-term fixed-rate charters. Seaspan's fleet of 68 containerships consists of 30 existing containerships and 38 to be delivered over approximately the next three years. The 38 vessels that Seaspan has contracted to purchase are already committed to long-term time charters averaging approximately 11 years in duration from delivery. Seaspan's operating fleet of 30 vessels has an average age of approximately five years with an average remaining charter period of approximately eight years. Seaspan's customer base consists of seven of the largest liner companies, including China Shipping Container Lines, A.P. Moller-Maersk, Mitsui O.S.K. Lines, Hapag-Lloyd, Coscon, K-Line and CSAV.

Seaspan's common shares are listed on the New York Stock Exchange under the symbol "SSW".
