



SEASPA^N ANNOUNCES \$235.3 MILLION IN DEBT FINANCING

Company Increases Access to Capital and Strengthens Financial Flexibility

HONG KONG, CHINA - April 4, 2008 /CNW/ - Seaspan Corporation (NYSE:SSW) announced today that it entered into a credit agreement for a term loan facility in the amount of \$235.3 million to finance the acquisition of two of its previously acquired 13100 TEU vessels. The facility has been fully underwritten by Sumitomo Mitsui Banking Corporation at a weighted average rate of 0.70% over LIBOR. Since January of 2007, Seaspan has raised more than \$2.2 billion of debt at a weighted average margin of less than 0.60% in support of its strong growth initiatives.

Gerry Wang, Chief Executive Officer of Seaspan, stated, "Our continued ability to raise funds at favorable rates during a challenging market environment underscores our growth prospects and our strong reputation among leading lending institutions. Including our latest debt financing, we have locked in attractive fixed rates for all of our credit agreements that more than fully fund our debt needs for our contracted fleet of 68 vessels. Currently, we have approximately \$550 million in immediate liquidity to capitalize on future acquisition opportunities that best serve the interests of shareholders."

About Seaspan

Seaspan owns containerships and charters them pursuant to long-term fixed-rate charters. Seaspan's contracted fleet of 68 containerships consists of 29 containerships in operation and 39 containerships to be delivered over approximately the next 4 years. Seaspan's operating fleet of 29 vessels has an average age of approximately 5 years and an average remaining charter period of approximately 8 years. All of the 39 vessels to be delivered to Seaspan are already committed to long-term time charters averaging approximately 11 years in duration from delivery. Seaspan's customer base consists of seven of the world's largest, publicly traded liner companies, including China Shipping Container Lines, A.P. Moller-Maersk, Mitsui O.S.K. Lines, Hapag-Lloyd, COSCO Container Lines, K-Line and CSAV.

Seaspan's common shares are listed on the New York Stock Exchange under the symbol "SSW".
